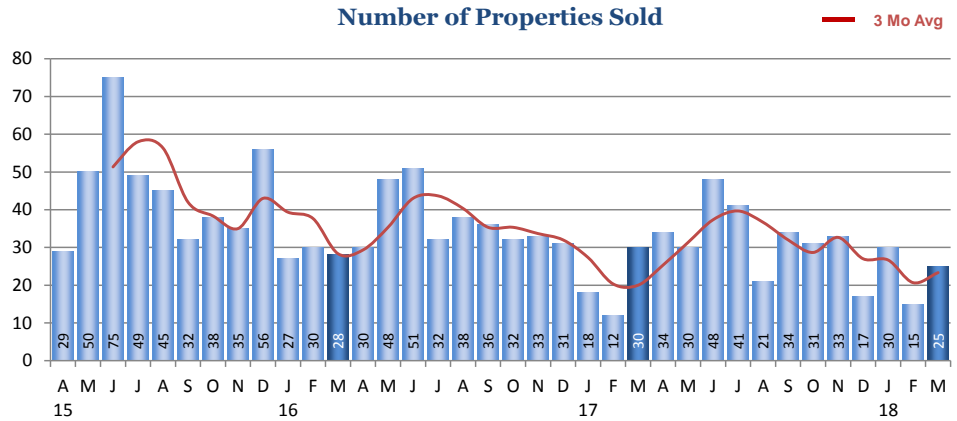

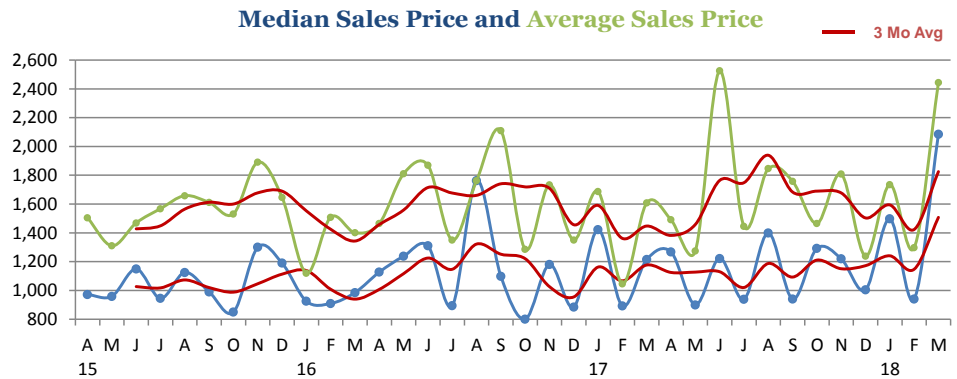
Property Sales

March Property sales were 25, down 16.7% from 30 in March of 2017 and 66.7% higher than the 15 sales last month. March 2018 sales were at their lowest level compared to March of 2017 and 2016. March YTD sales of 70 are running 16.7% ahead of last year's year-to-date sales of 60.



Prices

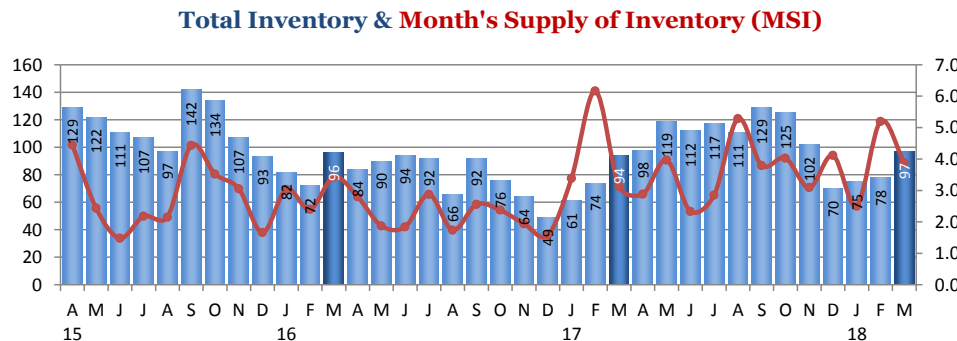
The Median Sales Price in March was \$2,085,000, up 71.6% from \$1,215,000 in March of 2017 and up 121.8% from \$940,000 last month. The Average Sales Price in March was \$2,443,181, up 51.9% from \$1,608,050 in March of 2017 and up 88.4% from \$1,296,843 last month. March 2018 ASP was at the highest level compared to March of 2017 and 2016.



Inventory & MSI

The Total Inventory of Properties available for sale as of March was 97, up 24.4% from 78 last month and up 3.2% from 94 in March of last year. March 2018 Inventory was at its highest level compared with March of 2017 and 2016.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The March 2018 MSI of 3.9 months was at its highest level compared with March of 2017 and 2016.



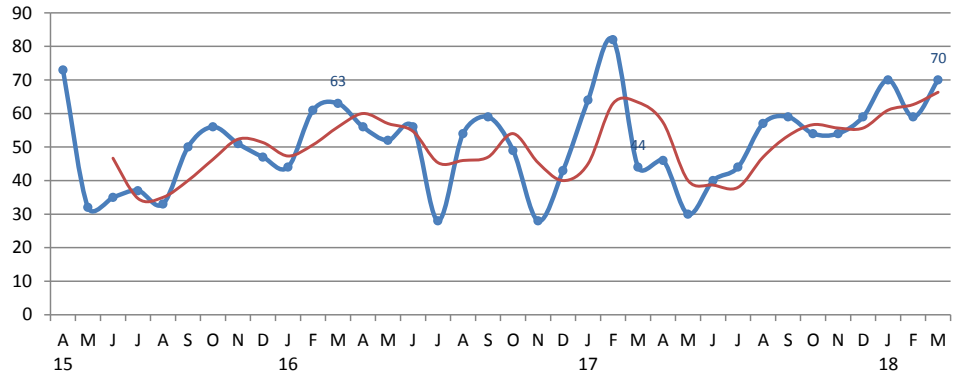

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for March was 70, up 18.6% from 59 days last month and up 59.1% from 44 days in March of last year. The March 2018 DOM was at a mid level compared with March of 2017 and 2016.

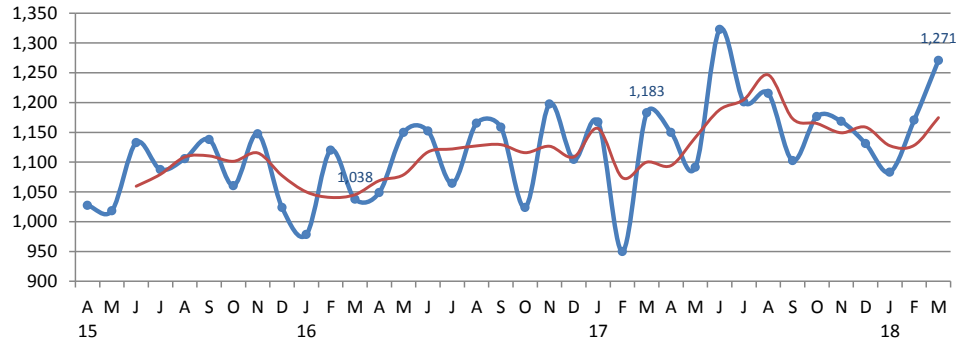
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The March 2018 Selling Price per Square Foot of \$1,271 was up 8.6% from \$1,170 last month and up 7.4% from 1,183 in March of last year.

Selling Price vs Original Listings Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The March 2018 Selling Price vs Original List Price of 95.2% was down from 102.7% last month and down from 100.1% in March of last year.

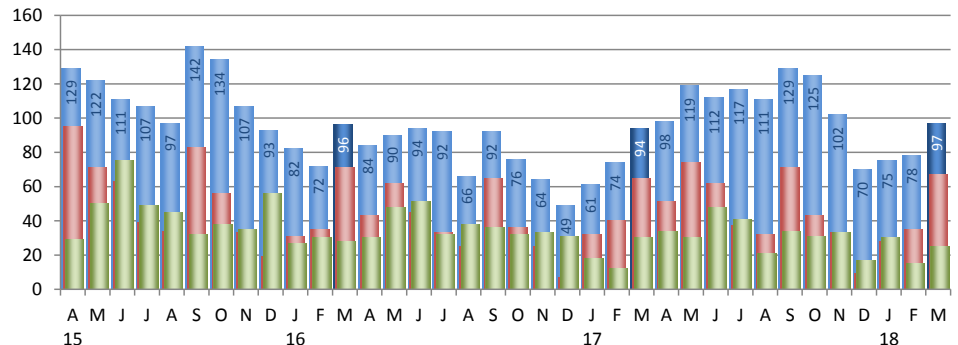
Selling Price versus Listing Price Ratio

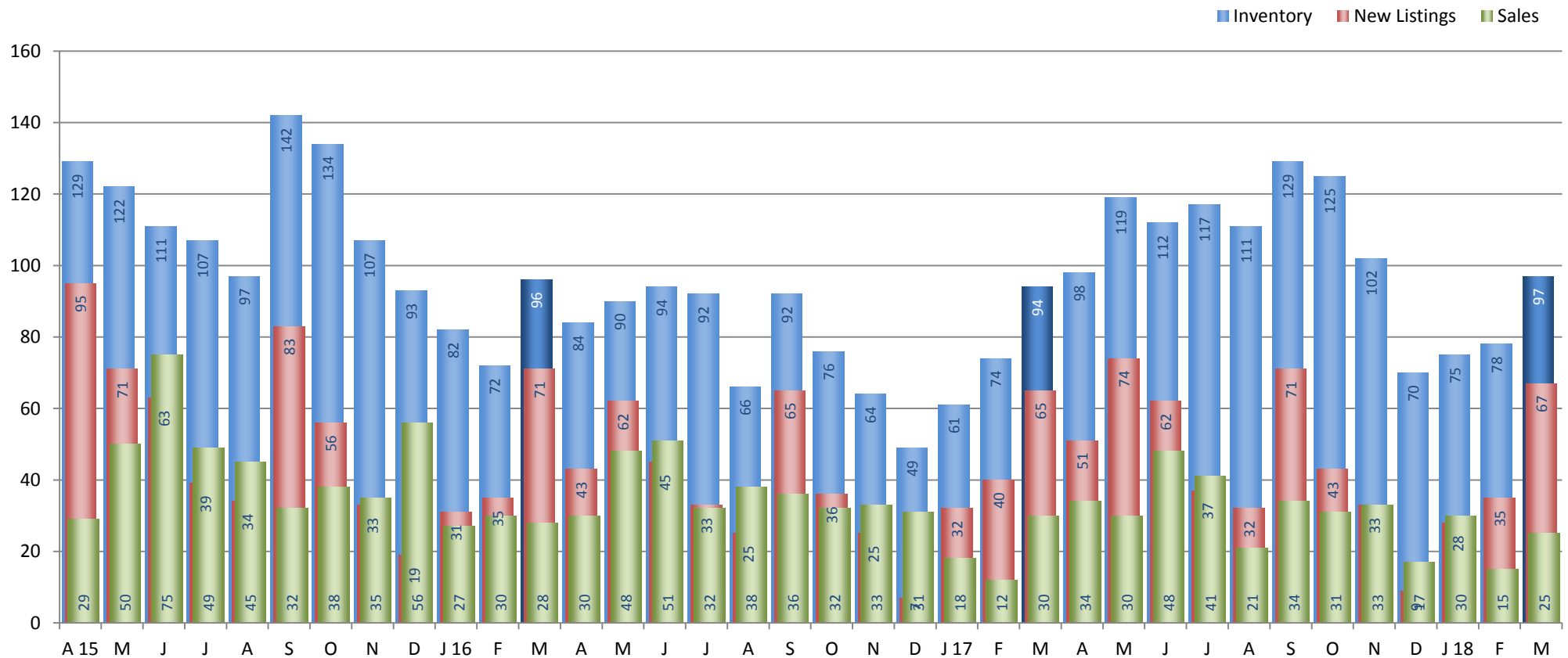
