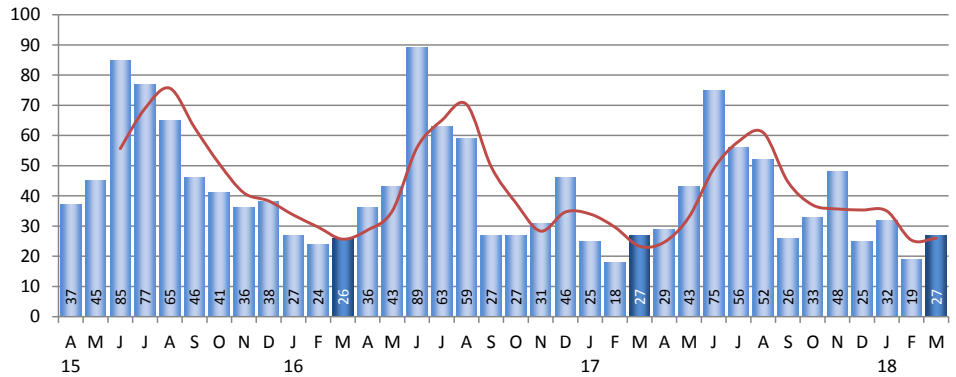

Property Sales

March Property sales were 27, equal to 27 in March of 2017 and 42.1% higher than the 19 sales last month. March 2018 sales were at their highest level compared to March of 2017 and 2016. March YTD sales of 78 are running 11.4% ahead of last year's year-to-date sales of 70.

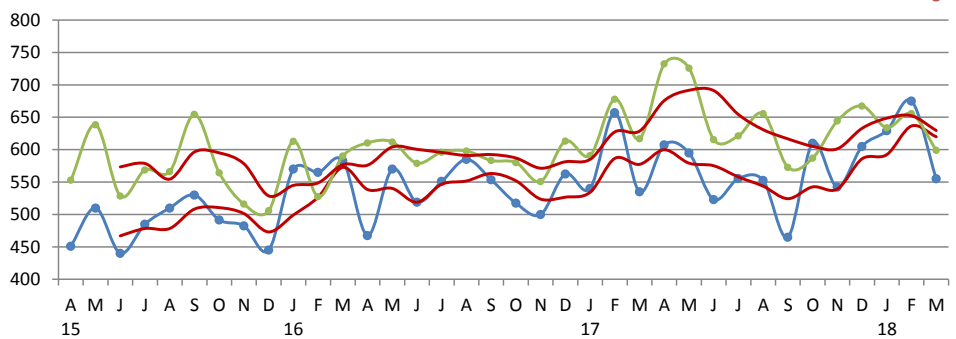
Number of Properties Sold



Prices

The Median Sales Price in March was \$555,000, up 3.7% from \$535,000 in March of 2017 and down 17.8% from \$675,000 last month. The Average Sales Price in March was \$599,164, down 2.9% from \$616,778 in March of 2017 and down 8.6% from \$655,500 last month. March 2018 ASP was at a mid range compared to March of 2017 and 2016.

Median Sales Price and Average Sales Price

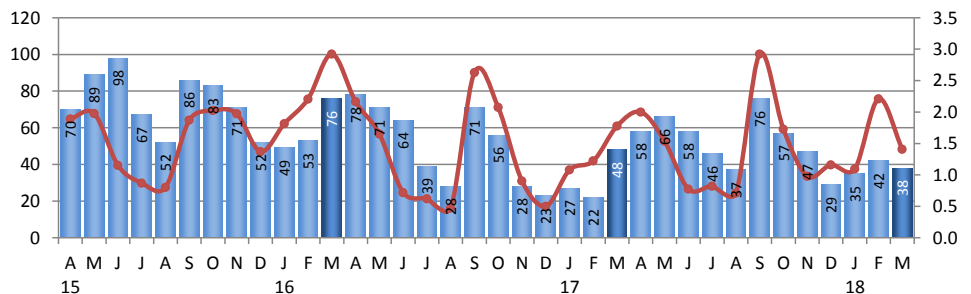


Inventory & MSI

The Total Inventory of Properties available for sale as of March was 38, down 9.5% from 42 last month and down 20.8% from 48 in March of last year. March 2018 Inventory was at its lowest level compared with March of 2017 and 2016.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The March 2018 MSI of 1.4 months was at its lowest level compared with March of 2017 and 2016.

Total Inventory & Month's Supply of Inventory (MSI)



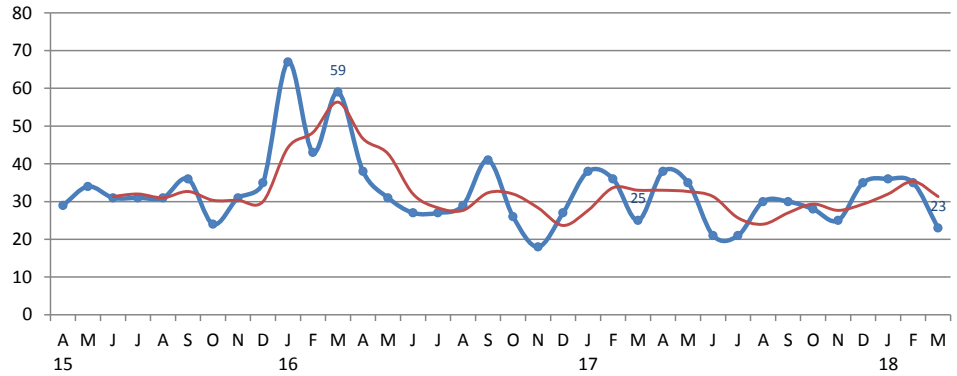

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for March was 23, down 34.3% from 35 days last month and down 8.0% from 25 days in March of last year. The March 2018 DOM was at its lowest level compared with March of 2017 and 2016.

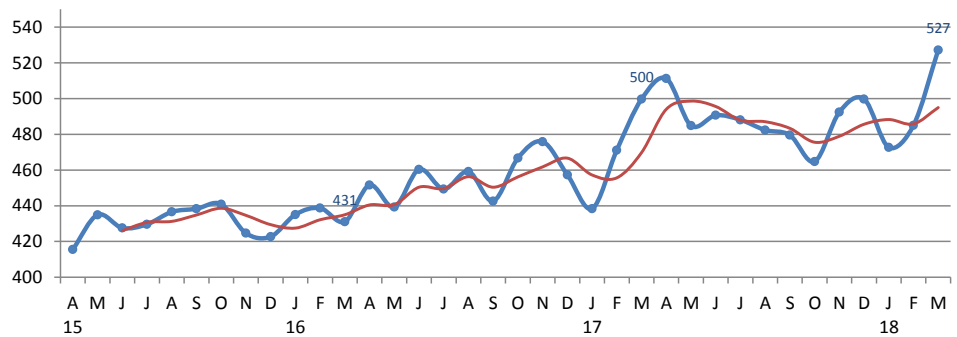
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The March 2018 Selling Price per Square Foot of \$527 was up 8.7% from \$485 last month and up 5.5% from 500 in March of last year.

Selling Price vs Original Listings Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The March 2018 Selling Price vs Original List Price of 104.3% was up from 99.8% last month and down from 104.5% in March of last year.

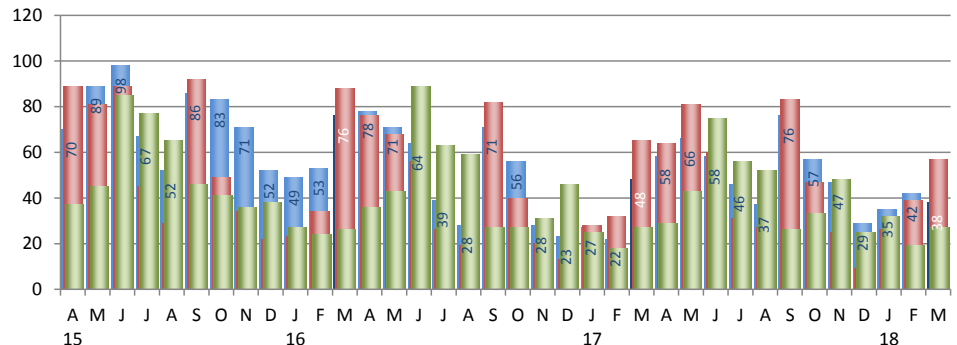
Selling Price versus Listing Price Ratio

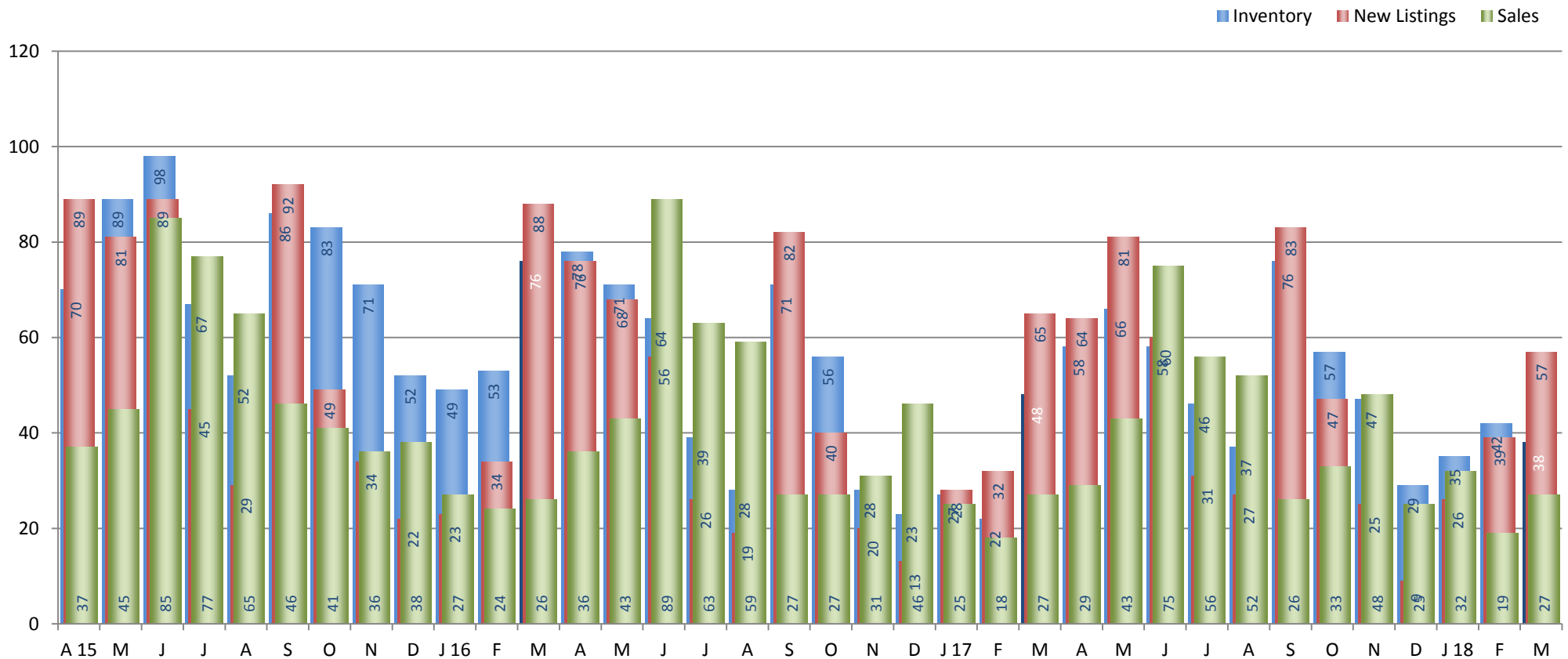
