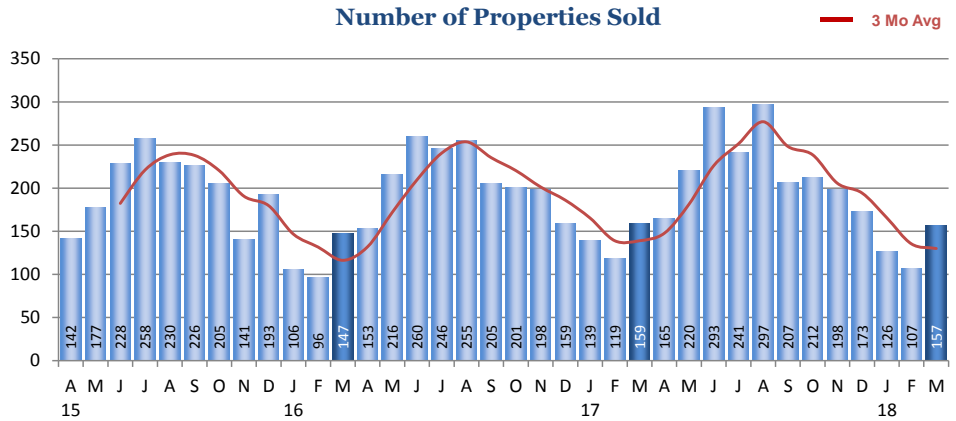

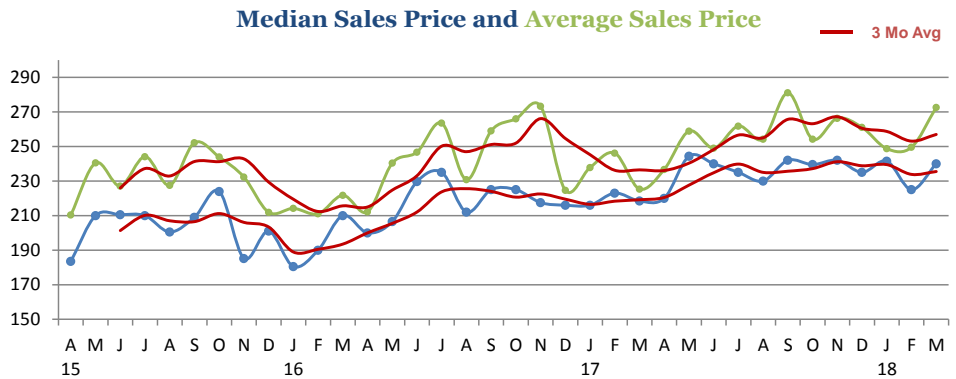
Property Sales

March Property sales were 157, down 1.3% from 159 in March of 2017 and 46.7% higher than the 107 sales last month. March 2018 sales were at a mid level compared to March of 2017 and 2016. March YTD sales of 390 are running 6.5% behind last year's year-to-date sales of 417.



Prices

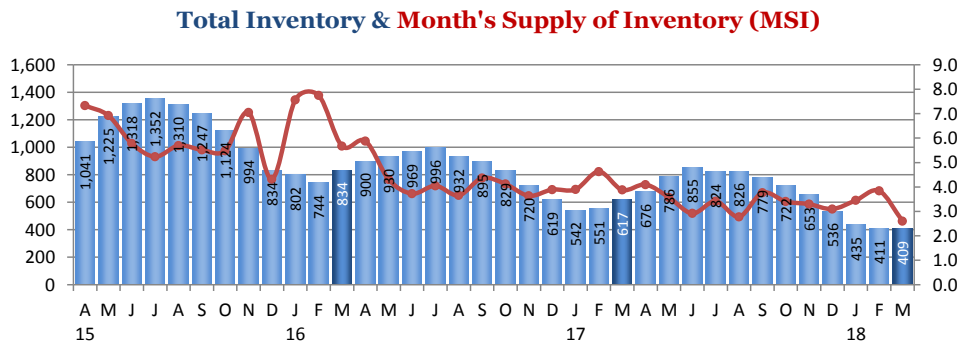
The Median Sales Price in March was \$240,000, up 9.9% from \$218,450 in March of 2017 and up 6.7% from \$225,000 last month. The Average Sales Price in March was \$272,647, up 21.0% from \$225,352 in March of 2017 and up 9.3% from \$249,523 last month. March 2018 ASP was at the highest level compared to March of 2017 and 2016.



Inventory & MSI

The Total Inventory of Properties available for sale as of March was 409, down 0.5% from 411 last month and down 33.7% from 617 in March of last year. March 2018 Inventory was at its lowest level compared with March of 2017 and 2016.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The March 2018 MSI of 2.6 months was at its lowest level compared with March of 2017 and 2016.



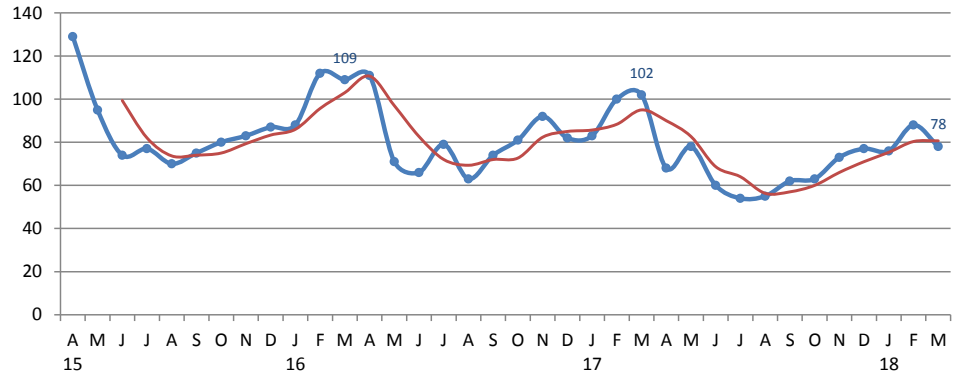

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for March was 78, down 11.4% from 88 days last month and down 23.5% from 102 days in March of last year. The March 2018 DOM was at its lowest level compared with March of 2017 and 2016.

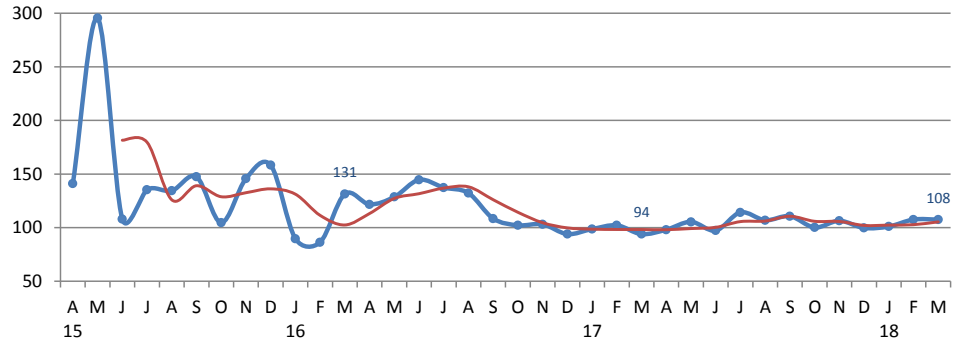
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The March 2018 Selling Price per Square Foot of \$108 was down 0.0% from \$108 last month and up 14.4% from 94 in March of last year.

Selling Price vs Original Listings Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The March 2018 Selling Price vs Original List Price of 96.9% was up from 94.8% last month and up from 94.9% in March of last year.

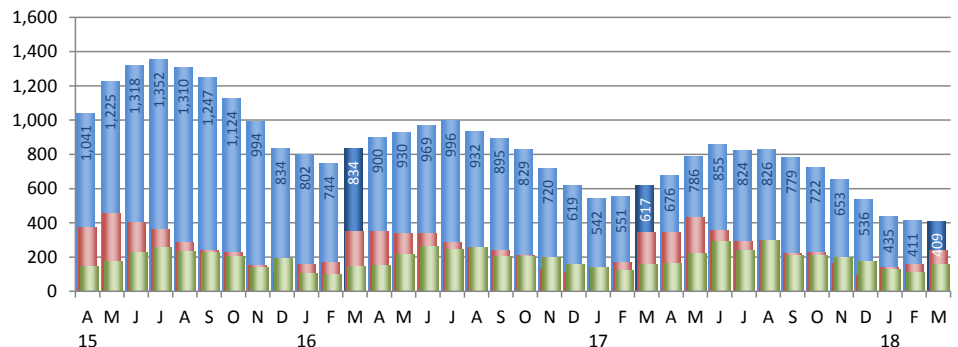
Selling Price versus Listing Price Ratio

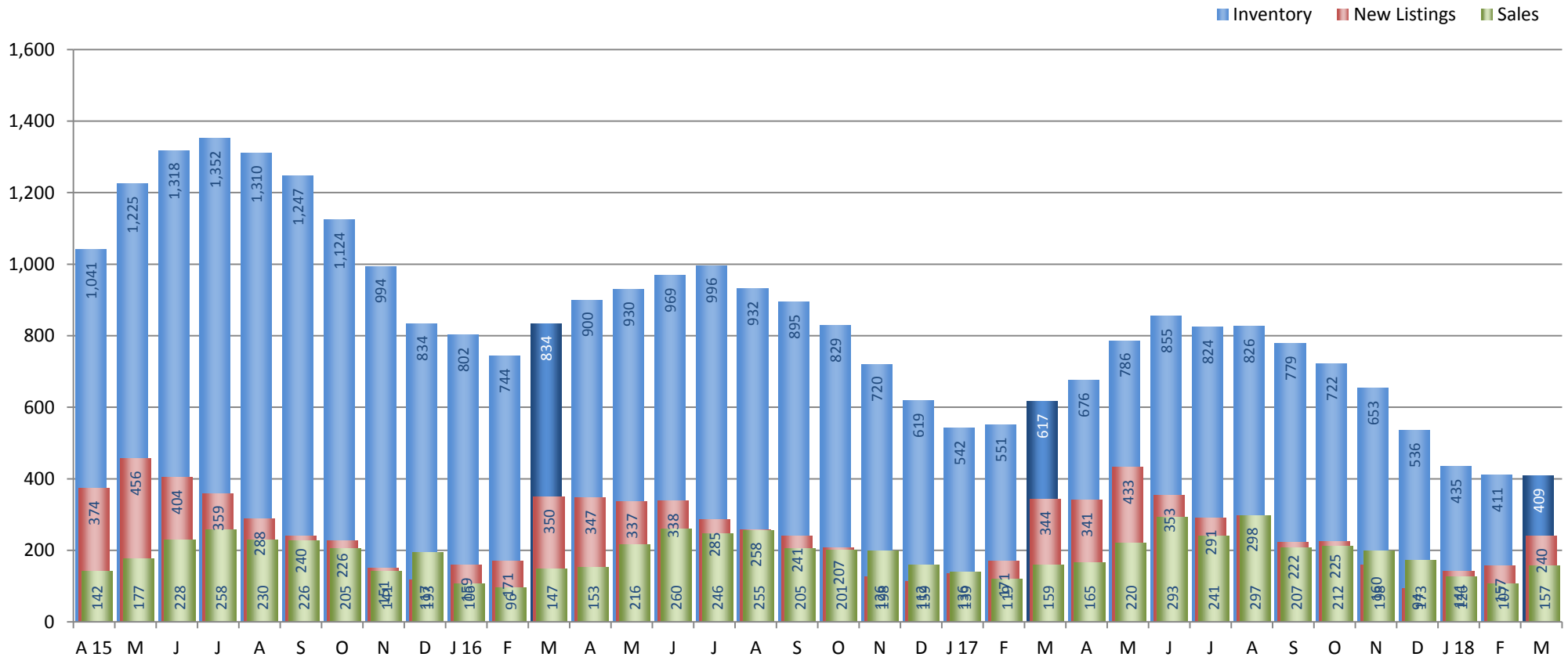
